### Position Overview:

The **Summer Events Facilitator** will collaborate with the Summer Events Director and CPBC staff to plan, organize, and execute summer gatherings designed to connect the church with the local community and provide discipleship opportunities for Compass Point families and caregivers. Key responsibilities include vendor management, volunteer recruitment and training, safety protocol implementation, and building relationships with participants. This role offers a fun, hands-on opportunity to gain practical ministry experience by bringing Biblical themes to life for various ages, tailored to the unique rhythm of summer.

### Responsibilities:

#### Creative event planning:

- Partner with the Compass Point Kids and Youth teams to conceptualize and execute four community events and three family discipleship gatherings.

#### Communication and team building:

- Promote and bring awareness within the congregation and local community. Manage volunteers, including recruitment, training, and ongoing mentorship to bring the vision to life.

#### Leadership & Execution:

- Oversee event logistics, connect with vendors, and delegate responsibilities, working in coordination with the Compass Point Staff to ensure alignment with the Compass Point Mission and Values.

#### Professional Development:

- Grow in a theological understanding of family ministry within the church.
- Engage in church-wide opportunities, supporting additional ministries and tasks as requested.



### **Ideal Qualifications:**

- Committed follower of Jesus Christ with an authentic lifestyle demonstrating consistent character and spiritual growth
- In full agreement with CPBC's Mission, Values, and Beliefs
- Must be between the ages of 15 and 30 at the start of employment and be authorized to work in Canada
- Must complete Plan to Protect training (provided) and apply for a Criminal Background Record check (provided).
- Ability to work well in a team environment
- A desire to think theologically about ministering to community members and families in the church
- Demonstrates flexibility, humility, and a desire to complete tasks accordingly and in a timely manner.

### **Experience and Education:**

Though not strictly required, the ideal candidate

- Has previous experience serving in the church (volunteer or paid)
- Is enrolled in a post-secondary program
- Is studying to enter a vocation/ministry related to children, youth and/or families
